Amazon Filters Ltd is committed to full compliance with all applicable UK strategic export controls and regularly reviews its operations to ensure that our products are not subject to export restrictions, including those concerning dual-use items listed in the relevant consolidated schedules.

In addition, we adhere to OECD guidance and all relevant UK, EU and US legislation on responsible sourcing of minerals, and require our supply chain partners to maintain these same high standards.
